Doctor Harisingh Gour Vishwavidyalaya

Doctor Harisingh Gour Vishwavidyalaya Sagar (A Central University), formerly University of Saugor, was established on 18th July 1946 by Doctor Sir Hari Singh Gour (Nov. 26, 1870 – Dec. 25, 1949) by his lifetime savings. This 18th University of India and the oldest and the biggest University of Madhya Pradesh has perhaps the singular distinction of being founded by the munificence of a single person's hard earned money of about two crores of rupees. Apart from being a great jurist and legal luminary par excellence, he was a great Patriot, Philanthropist, Educationist and Social Reformer. Doctor Hari Singh Gour was the first Vice-Chancellor of University of Delhi (1922 to 1926). Doctor Hari Singh Gour also held the position of Vice-Chancellor of the Nagpur University, (two times in 1928 and 1936).
