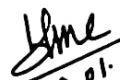

MINIMUM QUALIFICATION:

- (A) (i) An eminent scholar having a Ph.D. degree in the concerned/allied/relevant discipline **with the specialization in Dr. Ambedkar's Thought & Philosophy/ Education, Social justice/ Inclusion/ Harmony** and published work of high quality, actively engaged in research with evidence of published work with, a minimum of 10 research publications in the peer-reviewed or UGC-listed journals and a total research score of 120 as per the criteria given in the Appendix-II, Table 2.
- (ii) A minimum of ten years of teaching experience in university/ college as Assistant Professor/ Associate Professor/ Professor, and/or research experience at equivalent level at the University/ National Level Institution with evidence of having successfully guided doctoral candidate.

OR

- (B) An outstanding professional, having Ph.D. Degree in the relevant/ allied/concerned disciplines, from any academic institutions (not included in A above)/ industry, who has made significant contribution to the knowledge in the concerned/ allied/ relevant discipline, supported by documentary evidence provided he/she has ten years' experience.

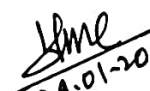
1. Applicants are required to apply online through link: <https://dhsgsu.edu.in> . Link for online application is also available on UGC CU Chayal Portal <https://curec.samarth.ac.in/>). The online link will be available till 29/02/2024.
2. As far as possible preference may be given to the persons belonging to SC, ST, OBC or those belonging to other Weaker Sections of the Society in the selection to the post of Chair Professor.
3. Applications incomplete in any respect and not accompanied with relevant certificates/documents/photographs/copies or orders etc., as desired or without requisite fee will be summarily rejected.
4. Candidates are advised to satisfy themselves before applying that they possess essential qualifications laid down in the advertisement.
5. The applicants serving in Government/Semi-Government organization/Public Sector Undertaking/Autonomous organization must upload the NoC issued by their employer. In case the candidate is unable to get NoC from his/her employer due to whatsoever reasons at the time of application, he/she may apply online as advance copy and NoC may be submitted at time of interview, failing which his/her candidature will not be considered and he may not be allowed to appear in the interview.
6. The candidates from private organizations or from govt. organization working under self-finance scheme are required to submit Form-16 for claiming their monthly emoluments in support of their claimed experience.
7. Mere eligibility will not entitle any candidate for being called for interview. Applicants having higher qualification and merit will be given preference.
8. The candidates will be called for interview, wherever applicable, by the University on the recommendations of Screening-Cum-Scrutiny Committee.
9. Experience and qualification will be reckoned as on the last date of submission of online application.
10. The service conditions including AGP and age of superannuation shall be as per UGC/University Rules/Norms.

11. SC/ST and PWDs Candidates must enclose with application the hard copy of the Caste Certificate/Medical Certificate in GOI prescribed format duly issued by the competent authority.
12. The University will get verified all the certificates in support of qualification, experience etc. submitted by candidates, from the issuing authority. If any document is found to be false/ fake/ incorrect/ malafide at any stage of verification before or after appointment, the document in question shall be summarily rejected and action may be initiated against the candidate for this misconduct including rejection of his/her candidature which shall lead to termination of his/her appointment.
13. The appointment will be subject to police verification. In case, the report of police with regard to his/her conduct, character, antecedent etc. is not found to be satisfactory, the provisional appointment shall be withdrawn/ cancelled/ terminated forthwith without notice.
14. In case of any inadvertent mistake in the process of selection, which may be detected at any stage even after the issue of appointment letter, the University reserves right to modify/withdraw/cancel any communication made to the candidate.
15. In case of any dispute/ambiguity that may occur in the process of selection, the decision of the University shall be final.
16. Candidates must enclose self-attested copies of certificates and mark-sheets from matriculation (10th Standard) onwards in support of their qualifications and reprints of publications and certificates in support of their claim for the post along with the application form.
17. Canvassing in any form will be a disqualification.
18. No interim correspondence shall be entertained.
19. In case of any dispute, suite or legal proceedings against the University, the jurisdiction shall be restricted to the Hon'ble High Court of Madhya Pradesh, Jabalpur (M.P.).
20. The service contract may be terminated at any time with one month's prior notice by the university or one month salary may be paid in absence of notice without assigning any reason. The candidate is also required to give one month's advance notice or else deposit one month's salary; in case the candidate is leaving during the contract period.

21. After joining the position under Dr. Ambedkar Chair, the candidates will have to abide by the Rules, Regulations and Ordinances of the University/ Rules of UGC/Rules of Govt. of India applicable from time to time. S/he may be assigned any duty within/outside the University depending upon the exigencies of the work.
22. **The appointment is purely on deputation/ contractual basis.**
23. The selection procedure for Chair Professor shall be as laid down by the UGC Regulations on Minimum Qualifications for Appointment of Teachers and Other Academic staff in Universities and Colleges and Measures for maintenance of Standards in Higher Education, 2018 and as amended from time to time and as per guidelines of Dr. Ambedkar Foundation, Ministry of Social Justice & Empowerment, Govt. of India.
24. A Relaxation of 5% may be provided for the teaching post at the Graduate and Master's level for the SC/ST/Differently-abled (Physically and Visually differently-abled)/Other Backward Classes (OBC) (Non-creamy layer) categories for the purpose of eligibility and for assessing good academic record. The eligibility marks of 55% marks (or an equivalent grade in a point scale wherever grading system is followed) and the relaxation of 5% to the categories mentioned above are permissible, based on only the qualifying marks without including any grace mark.
25. A relaxation of 5% may be provided, from 55% to 50% of the marks to the Ph.D. degree holders, who have obtained their Master's Degree prior to 19th September, 1991.
26. Candidates awarded degree by Foreign Universities are required to submit Equivalence Certificate issued by Association of India University, New Delhi.
27. Only online applications will be accepted.
