Sir/Madam,

This is to inform you that the Hon'ble High Court of Punjab & Haryana, in its interim order dated **27 May 2025** in **CWP No. 15106 of 2025**, titled "*Gurshaan Singh Cheema vs Union of India & Others*", has issued the following directions with respect to the Political Science subject (HUQP18) under CUET (PG) – 2025:

"Any admission to the course in question shall remain subject to outcome of this petition."

"The selected candidates who are appearing for counselling as well as those who are getting admitted to the course be informed of pendency of the petition by the respondents."

Since the NTA's role is confined to the registration, conduct of the test, display of answer keys, processing challenges, finalizing results, and hosting of scorecards, the responsibility of implementing these directions during admissions rests with the concerned universities.

In this regard, you are therefore requested to:

1. Display or include the following advisory in your Political Science counselling/admission process:
"Admission to the Political Science programme is subject to the outcome of CWP No. 15106 of 2025 pending before the Hon'ble High Court of Punjab & Haryana."
2. Maintain internal documentation/records of such disclosure for compliance purposes.

This communication is being sent only to those participating universities that are offering Political Science and are using CUET (PG) - 2025 scores.
