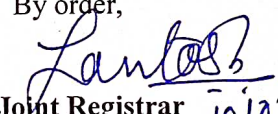

Prof. Naveen Kango, DoAA, extended a warm welcome to the Chairperson and all esteemed members, while also explaining the purpose behind convening the Emergent Meeting of the APC. Following this, the agenda items were discussed.

APC:EM:54:(01): Adoption of UGC Guidelines.

The UGC has framed various Regulations and Guidelines with respect to smooth Implementation of NEP-2020, which are listed below:

1. National Higher Education Qualification Framework (NHEQF)
(UGC publication - May, 2023)
2. National Credit Framework (NCrF)
(UGC publication- April, 2023)

Resolution: After due deliberations, the APC resolved to adopt the aforementioned UGC guidelines.

APC:EM:54:(02): Ph.D. Admission Brochure Session 2024-25.

Prof. Diwakar Shukla, Coordinator, Admission Cell placed the draft Ph.D. Admission Brochure for the academic session 2024-25, before the APC.

Resolution: After thorough deliberations, the APC resolved to return the Ph.D. Admission Brochure to the Admission Cell for further corrections and changes, as suggested by the APC members, and to present it at the next APC meeting for consideration.

APC:EM:54:(03): Bye-Laws of Gour Peeth.

A duly constituted committee of Gour Peeth has formulated the By-Laws for the smooth functioning of the Peeth, which was placed before the APC.

Resolution: The APC after due deliberations resolved to approve the item under the captioned agenda.

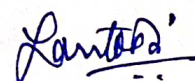
APC:EM:54:(04): Admission/ Registration of Prof. Ratnesh Das for D.Sc. Programme.

The BoS of the Department of Chemistry in its meeting held on 25.01.2022 has approved the Admission/ Registration of Prof. Ratnesh Das in D.Sc. Programme and appointed Prof. A.P. Mishra as his advisor for this programme. Thereafter, the matter was placed before APC in its 30th regular meeting held on 16.08.2022. During the meeting, it was resolved to place the matter agenda again with full facts and rules.

Thereafter, the BoS of Department of Chemistry through its meeting dated 10.10.2023 reviewed the relevant documents submitted by Prof. Ratnesh Das, which was forwarded to DoAA Section on 04.11.2024 for further consideration of the APC.

Resolution: After thorough deliberations, the APC resolved to refer the matter under the captioned agenda back to the BoS of the Department of Chemistry for examination in light of the relevant University Ordinance and prevailing rules. The BoS's recommendation may then be placed before the APC.

APC:EM:54:(05): The recommendations of DRC, Dept. of Botany dated 10.01.2025.

The meeting of the DRC, Dept. of Botany was held on 10.01.2025. The resolution of DRC is regarding the issue of continuance of Ph.D. of 02 Female Research Scholars Ms. Farhat Khan, Reg. No. Y16461006 dated 05.10.2016 and Ms. Subalakshmi Rout, Reg. No. Y16461008 dated 05.10.2016. The DRC recommended that as per Clause No. 4 of the UGC Regulation-2022 and the endorsement of RAC, both the Research Scholars may be permitted for re-registration.

Resolution: The APC after due deliberations resolved to approve the item under the captioned agenda.

APC:EM:54:(06): The recommendations of DRC, Dept. of Applied Geology dated 10.09.2024.

The meeting of the DRC, Dept. of Applied Geology was held on 10.09.2024. The resolution of DRC is regarding the issue of continuance of Ph.D. of Research Scholar Mr. Abhishek Tiwari, Reg. No. Y17451005 dated 23.08.2017. The DRC recommended that as per the UGC Regulation-2022 and Clause No. 4.1(2) of University Ordinance 23(A) (Amended), the concerned Scholar may be permitted for re-registration.

Resolution: After thorough deliberations, the APC resolved to approve the item under the captioned agenda.

Additionally, it was decided that research scholars who require an extended duration to complete their Ph.D. program must apply for re-registration or extension before the completion of the initial duration, in accordance with the prevailing Statutes and Ordinances of the University.

APC:EM:54:(07): Proposal of New Certificate Courses.

Following courses were recommended by the Ad-hoc BoS of College of Paramedical Sciences in its meeting dated 05.02.2025 :-

1. Certificate Course in Biomedical Waste Management
2. Certificate Course in Clinical and Therapeutic Nutrition.

Resolution: After thorough deliberations, the APC approved both proposals in principle, as received from the College of Paramedical Sciences. It was further resolved that the fee structure for the proposed courses should be duly approved by the Fee Committee/Finance Committee of the University.

With the permission of the Chair, the following items were taken up :

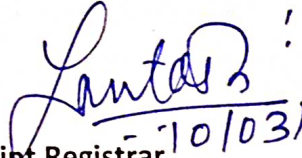
- a) Proposal of Establishing Centre of Mathematical Finance and to initiate a Certificate Course in Financial Mathematics.
