### **SYLLABUS**

### Pre-Ph. D. Course Work (ENGLISH)

### A General Introduction to the Program:

The student admitted to the Ph.D Programme shall be required to undertake the Pre-Ph.D Course Work in the First semester. The Course Work shall consist of Two Core Papers and one Elective Paper of 4 credits each. The Review of Literature shall be of 4 Credits and shall be compulsory. The student will thus be required to undertake a minimum of 16 credits during the First Semester.

### **Scheme of Examination**

All Programs of Studies of the University follows the Semester system and examination and evaluation of students is through Comprehensive Continuous Internal Assessment (CCA).
