Item No. 1: Information regarding the formation of Students' Council for the session 2013-14.

Note: The list is provided by the Dean of Students Affairs.

Resolution: The committee noted the formation of Students' Council for the session 2013-14. **(Annexure-1, pg 1-3.)**

Item No. 2: Putting on hold the M. Phil. Program for session 2014-15.

Note: Apart from the NET/SLET/SET, Ph. D. degree awarded in accordance with the University Grants Commission (Minimum Standards and Procedure for Award of Ph. D. Degree) is the criteria for selection for recruitment and appointment of Assistant Professors in Universities / Colleges / Institutions.

Resolution: The committee noted that there is no utility of the M. Phil. Program, as M. Phil. program is no longer the eligibility criteria for selection for recruitment and appointment of Assistant Professors in Universities / Colleges / Institutions.

Hence, the committee resolved not to hold the admission for M.Phil. Program in the session 2014-15.

Item No 3: Consideration of the following minutes of DPGC of Department of Botany.

Resolution: (a) The committee resolved to accept the recommendation of DPGC of the Department of Botany to change the supervisor of Ku. Vandana Bharty. As recommended by the DPGC, The new supervisor for Ku. Vandana Bharty will be Dr. Archana Mehta.

- (b) The committee resolved that the candidate be issued a notice by the Head of the Department of Botany, to report within 15 days, failing which her candidature for Ph. D. program shall be terminated.

Item No 4: Education Tour from session 2014-15 onwards

Note: It has been reported that some Departments want to send the students on Educational Tour without any regards to course requirements. It causes audit and financial problems.

Resolution: The committee resolved that Educational Tour shall not be allowed, where it is not part of syllabi. Even if the tour form part of syllabi, it should be credit based, otherwise no permission shall be granted for Educational Tour. In any case, permission for Educational Tour shall not be granted during semesters.

WPC 1: Approval of Integrated Master of Social Work (M.S.W., a 5-years integrated program) in the School of Humanities and Social Sciences (in the Department of Sociology and Social Work).

Note: The Committee in its resolution no. 13 and 14 of 10th meeting of APC has resolved that any new program may be started as an integrated program only. **(Annexure-5)**

Resolution: The Committee agrees in principle to start the Master of Social Work program (M.S.W., 5-years integrated program, with entry at 10+2 level) in the School of Humanities and Social Sciences (in the Department of Sociology and Social Work).

However, the Chairman, Academic Council should be satisfied that necessary infrastructure exists for the program. The concerned Head of the Department should apprise the Hon'ble Vice-Chancellor/ Chairman, Academic Council and obtain explicit permission to start the program.

WPC 2: Approval of Integrated Master of Performing Arts (5-years integrated program) in the School of Arts and Information Sciences (in the Department of Fine Arts and Performing Arts). **(Annexure-5)**

Resolution: The Committee agrees in principle to start the Master of Performing Arts (5-years integrated program, with entry at 10+2 level) in the School of Arts and Information Sciences (in the Department of Fine Arts and Performing Arts).

However, the Chairman, Academic Council should be satisfied that necessary infrastructure exists for the program. The concerned Head of the Department should apprise the Hon'ble Vice-Chancellor/ Chairman, Academic Council and obtain explicit permission to start the program.
