The UGC vide its notification dated 23-06-2017 has published Open and Distance Learning Regulations, 2017. The same is placed before the Committee for adoption.

Resolution:

The APC resolved to adopt the UGC (Open and Distance Learning) Regulations, 2017 for its Institute of Distance Education (IDE) and to follow the same *in-toto* till the formation of Ordinance.

APC:23:5(1):

To consider induction of 04 new programs under Institute of Distance Education (IDE) of the Vishwavidyalaya

Presently, the IDE is running the following 11 programs and has sought further approval to run these programs:

- Master of Library & Information Science
- 2. Bachelor of Library & Information Science
- 3. Master of Journalism (Communication)
- 4. Bachelor of Journalism (Communication)
- 5. P.G. Dip. In Environmental Management
- 6. P.G. Diploma in Personnel Management
- 7. P.G. Diploma in International Business & Export Management
- 8. P.G. Diploma in Psychological Counseling
- 9. P.G. Diploma in Yoga and Meditation
- 10. P.G. Diploma Yoga and Psychotherapy
- 11. P.G. Diploma in Yoga and Naturopathy

The IDE has revised the syllabi of on-going programs in accordance with the latest UGC Regulations and are placed before the Committee for approval.

The IDE also proposes to introduce 04 new programs viz B. Com., B.A., PG Diploma in Advertising and Public Relations and PG Diploma in Web Programming. The IDE has prepared their syllabi also and are placed before the Committee for consideration.

Resolution:

The APC after detailed deliberation resolved that 11 on-going programs being run by the Institute of Distance Education (IDE) may be continued further and also gave its concurrence to introduce following 04 new programs:

APC:23:5(5): Surrender of TC and Migration (Re-admission) by the Student

A few students who are pursuing a regular course of study in the teaching department of the University for their better prospects withdraw their TC and Migration. However, situation has arisen, where a student wants to continue his studies and wants to surrender the TC and Migration. There is no provision in the Ordinances to deal with such cases. There is a case in hand of Mr. Prateek Sahu, B.Sc. III Sem.

The matter is placed before the Committee for consideration.

Resolution: The APC after detailed deliberation, pros and cons, legal status of the student and other related issues involved; resolved not to permit to surrender the TC and Migration by the student as these were issued on his/her request.

APC:23:5(5): To consider revised schedule of Entrance Test of the Vishwavidyalaya
