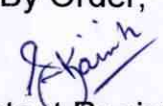

The Chairman welcomed all members and briefed the reason for calling this emergent meeting and thereafter the agenda was taken up:

EXIV:APC: I (1) Admission to B.A. program (entrance test code 110) for the session 2017-18 of the students appeared for B.A.B.Ed (entrance test code 111) of the Vishwavidyalaya

The Admission Cell vide their note sheet dated 19-07-2017 has informed that after two counselling, 177 seats are left vacant in the B.A. program (UR 79, OBC 52, SC 18 and ST 28) and proposed to allow the students who appeared for B.A.B.Ed. entrance test with code no.111. The details shall be presented by the Coordinator, Admission Cell.

The matter is placed before the APC for consideration.

Resolution:

The APC after detailed deliberation resolved that students who appeared in the entrance test for B.A. B.Ed. program (code 111) are permitted to take admission in B.A. program (code.110). The APC also resolved to allow the students who appeared for the entrance test of B. Lib. & I. Sc. Program (code 160) to take admission in Bachelor of Journalism program (code 161) and vice-versa, subject to availability of seats. This arrangement shall be for this year only. On the request of HoD (Music), the APC resolved to increase 05 seats in PG (Music).

The Counselling for the above shall be held on 31-07-2017.

EXIV:APC: I (2) To consider Counselling for the resultant seats for the session 2017-18

Two Counselling for admission to UG and PG has been done. However, there are some resultant seats. The proposal is to allow last counselling for the resultant seats for the session 2017-18

Resolution:

The APC after deliberation resolved that last counselling shall be held on 31-07-2017 for all the resultant vacancies in UG & PG Programs. Thereafter, no counselling shall be held.

EXIV:APC: I (3) To consider opening of new programs by 37 private colleges affiliated with the Vishwavidyalaya

The 22nd APC has constituted a committee. The Committee has examined the matter and mentioned that these colleges are affiliated with the Vishwavidyalaya by the order of Hon'ble High Court of

M.P. The Committee has mentioned that at present there is no role of M.P. State Govt. and Commissioner Higher Education, Govt. of MP regarding opening of new courses in these affiliated colleges. In the meantime, the NCTE has issued recognition letter for opening of B.A. B.Ed., B.Sc. B.Ed. and B.Ed to the following colleges:

1. Virangna Awanti Bai College, Chhatarpur
2. B.T. Institute of Excellence, Sagar
3. Times College of Education, Damoh
4. S.S. College of Computer and Professional Studies, Chhindwara
5. Pt. Bhagirah Bilgaiyan Memorial Technical and Professional College, Bina
6. Gyanveer Institute of Management and Sciences, Sagar

The matter is placed before the APC for consideration.

Resolution:

The APC after detailed deliberation resolved to accept the recommendations of the Committee to grant affiliation to start new courses, for which NOC has already been issued to the aforesaid colleges. However, approval for running part time courses shall be given only after completing necessary formalities. It further resolved that no NOC in future shall be issued to any other affiliated colleges.

EXIV:APC: I (4) Time limit to declare the result of Course Work of Ph.D. program

At present there is no time limit to declare the result of Ph.D. Course Work. The Ordinance 23 (A) provides that the Research Scholar shall submit the Research Proposal within four months after successful completion of the course work. The proposal is to fix the time limit to declare the result so that fellowship could be justified after the End Semester Examination.

The matter is place before the APC for consideration.

The APC after deliberation resolved that the result of Ph. D. Course shall be declared by the Examination Section within 10 days from the date of receipt of awards from the Departments.
