APC:EM:21(01): Ph.D. in Climate Change

SKMCCC/APCO/2018 dated 17-05-2018 has requested to promote Ph.D. in climate change.

The matter is placed before the APC for consideration.

Resolution: The APC resolved that all Heads of the Departments be requested to conduct the Ph.D. in Climate change, wherever feasible.

APC:EM:21(02): **Admission of International Student in Ph.D. Program**

Regional Director, Indian Council for Cultural Relations (ICCR) (Ministry of External Affairs), Bhopal (M.P.) vide his letter No.RO/BPL/2018-19/1630 dated 14-05-2018 has forwarded an application of Mohammed Hamed Mahmoud Alqaisi a resident of Palestine for admission to Ph.D. program (Forensic DNA/Molecular Biology/Biotechnology/Genetics) under ICCR scholarship. In case of admission, ICCR will provide tuition fee, admission fee, hostel fee, etc. after receiving the joining report by the applicant.

The matter is placed before the APC for consideration.

Resolution: The APC resolved that willingness be sought from the candidate through email.

APC:EM:21(03): **Special Counseling for Admission to UG and PG Programs for the Session 2018-19**

Two Counselings for admission to UG and PG programs have been held. The last counseling was held from 9 to 13 July 2018. A few seats are vacant and it is proposed to conduct a special counseling on 23 & 24 July 2018.

The matter is placed before the APC for consideration.

Resolution: The APC resolved to conduct special counseling on 23rd and 24th July 2018 for UG and PG respectively and Final counseling on 27th July 2018.

The APC resolved that the seats of SC/ST shall be filled by their respective category till 1.00pm on 23rd and 24th July 2018 for UG and PG programs respectively. If the seats of SC or ST remain vacant, even after reaching the last cut off 20% marks in the entrance examination and by interchanging also which will be their last chance, then the seats of SC/ST/OBC category will be changed to Un-reserved category on the same day after 1.00pm.

The APC resolved to increase 25 seats in B.Com. and 10 seats in MA/M.Sc. (Yogic Science) Programs.

APC:EM:21(06) III: Prof. Sanjay Jain, Dean School of Engineering & Technology informed the APC that the Department of Industrial Policy and Promotion, Government of India has launched Start Up India Yatra to disseminate knowledge about government policies and initiatives to strengthen start up ecosystem across the country. In this regard, Government of Madhya Pradesh is bringing out Start Up India Madhya Pradesh Yatra from 19th July to 3rd August 2018. During this Yatra 8 Boot Camps will be organized at different divisional head quarters. Based on incubation and entrepreneurial potentials, the M.P. Govt has considered Dr. Harisingh Gour Vishwavidyalaya, Sagar as one of the host institute for such Boot Camp to be organized on 25-07-2018.

APC:EM:21(06) IV: Faculty Recharge Program

Chairman apprised the APC that University Grants Commission is operating a scheme called Faculty Recharge Program. Under this scheme, UGC inducts fresh talent at the level of Assistant Professors, Associate Professors and Professors. This University has received a request letter with a brief CV from Dr. Santosh Kumar, Associate Research Scientist at Yale University, New Haven, USA for activation of faculty position (UGC-FRP) "Assistant Professor in Biological Sciences" in our University.

However, this university is yet to sign MoU with the UGC for facilitating activation of FRP. Accordingly, this University is required to sign a bipartite MoU with the UGC and subsequently a tripartite MoA is to be signed involving UGC, University and Dr. Santosh Kumar.

Resolution: The APC approved for signing of a bipartite MoU with the UGC and subsequently also a tripartite MoA involving UGC, University and Dr. Santosh Kumar for facilitating activation of UGC-FRP scheme in this Vishwavidyalaya.
