The MHRD vide its letter dated 08-08-2018 has call for participation from all Colleges/Universities/Institutions in 'Swachh Campus' Ranking of Higher Educational Institutions. Entries for 'Swachh Campus' ranking are open from 09-23 August 2018. Best 10 institutions will be selected on the basis of submissions and subsequent inspections of the campus. MHRD has mentioned that this is an important activity which gives greater visibility to your institution in terms of an essential aspect of campus life.

As per the decision of the 21st APC (emergent) a special counseling for admission to UG and PG Programs was held on 23, 24 and 27 July 2018. However, still 102 and 345 seats are vacant in UG and PG programs respectively.

The matter is placed before the APC for consideration.

Resolution: The APC resolved that considering the large number of seats, the Counseling may be held on 16-08-2018. However, in future, after prescribed counseling given in the admission brochure, no counseling should be held, as it will lead to litigation.

On an issue of re-valuation, it resolved that re-valuation should be allowed only in case of last semester of the course. It also resolved that re-totaling in any semester should be dispensed with.

Department of Chemistry due to oversight, the APC cautioned the Committee to be more careful in future and, as a special case, the candidate be asked to submit his final year result (V & VI semesters) latest by 30-08-2018, failing which his admission will get cancelled automatically.

However, considering the practical problems in conducting the classes as well as shortage of faculty, as a very special case their attendance will be relaxed.
