To discuss the issue of furnishing undertaking to strictly comply with the provisions contained in National Council for Teacher Education Act, 1993, as also, the provisionsl of Regulations framed thereunder, from time to time and also to strictly comply with provisions of MP Niji Vyavsayik Shikshan Sansthan (Pradesh ka Viniyaman Avam Shulk ka Nirdharan) Adhiniyam, 2007 and Rules framed thereunder for admitting students in the courses governed by the said Act.

It is informed to the APC that the Hon'ble High Court of MP at Jabalpur while deciding WP No.12458/2017: Centre for Higher Studies and Research B. Ed. College Vs State of Madhya Pradesh and Others vide its Order dated 06.09.2019 directed that all the members of the Academic Programme Committee will submit their undertaking with regard to the aforesaid effect.

Resolution:- The APC deliberated upon the draft of undertaking prepared by the Legal Cell and resolved to authorize Prof. P. P. Singh to check the undertaking and make necessary changes, wherever required. Further, resolved to sign the modified undertaking.

In a letter addressed to the Vice Chancellor, the Dean School of Biological Sciences raised the following issues and requested for clear cut guidelines so as to facilitate Screening of the Applications:-

- (i). Whether teaching experience of Assistant Professors appointed against Rolling Advertisement dated 30.10.2010 may be counted as teaching experience for the position of Associate Professors/ Professor or not?
- (ii). Whether experience as PDF may be counted as research experience for the position of Associate Professors/Professor or not?
- (iii). Whether any list of allied/relevant discipline has been prepared? If so, the same may be provided to the Screening Committee at the time of Screening.

Resolution:- The APC after due deliberation unanimously resolved:-

(i). Some of the Esteemed Members reiterated their earlier resolution passed in its 25th Meeting dated 18 September, 2019 that while considering the teaching experience of the Assistant Professors

appointed against Rolling Advertisement dated 30.10.2010, the provisions contained in clause-10.0 (f) must be adhered to in letter and spirit. However, some of the Esteemed Members were not agreed with the earlier resolution, In order to resolve the issue, the APC decided to seek Legal Opinion on the issue and further action may be taken as per advice rendered by the Legal Counsel.

- (ii) It was resolved that while considering the research experience of PDF, the provisions contained in clause-10.0 of UGC Regulations 2018 must be adhered to in letter and spirit.
- (iii) Since lists of allied/relevant disciplined duly approved by the concerned Board of Studies and School Board and also by the Academic Council before the date of advertisement are not available for all the subjects, it was resolved that in the current phase recruitment, only the concerned discipline should be considered at the time of Screening.

- Prof. A. P. Dubey and other teachers have jointly submitted to the Vice Chancellor a letter dated 09.10.2019, raising therein the following issues:
 - a. While considering the teaching experience of the Assistant Professors appointed against the Rolling Advertisement dated 30.10.2010, the provisions contained in clause 10.0 (f) must be adhered to in letter and spirit as resolved in the 25th Meeting of the APC: Clarification is required on the status of the Assistant Professors and Associate Professors working in this Vishwavidyalaya and applied for the Posts of Associate Professor and Professor, respectively,- under which category they fail - ad-hoc, temporary or contractual.
 - b. Clear cut guidelines are required: as to whether the journals placed in the list other than the UGC care list should also be considered.
 - c. Hard copy of the online applications must be made available to the Screening Committee for thorough screening of the applications.

Resolutions:-

The APC after due deliberations resolved as under:-

- a. It was already resolved to seek legal opinion on the issue and action may be taken as per the legal advice rendered by the Panel Advocate of the Vishwavidyalaya,
- It was resolved to also consider the journals listed in old UGC list which is uploaded on the UGC website and peer reviewed journals.
- c. It was resolved that hard copy of the online applications of the applicant shall be provided to the Screening Committee at the time of screening.

Chairperson of the APC informed the Committee that the Chairman and members of Recruitment Coordination Board (RCB), excepting Prof. Archana Pandey, DoFA, submitted twice in writing to the Vice Chancellor that they are not willing to endorse the recommendations of the Screening Committees as it was not there in the original Term of Reference of the RCB, After due deliberations, the APC resolved to dissolve the RCB and further resolved that the recommendations of the Screening Committee bearing the signature of the members of the respective Screening Committee shall be processed by the office of the Director of Faculty Affairs.
