APC:EM:32:(01) **To consider the issue of unequal weightage of the questions given in all the branches of the M.Tech. Entrance Test 2020-21 (Code-203).**

It is informed to the APC that representations were received by a group of students after conduct of Entrance Test and uploading of Answer Keys on the University Website regarding unequal weightage of questions given in the all the branches of the M.Tech. Entrance Test 2020-21 (Code-203), whereas, the syllabus prescribes that equal weightage should be given to the all the branches, specified therein. The aforesaid representations were endorsed by Hon'ble Member of Parliament, Sagar Constituency. In this regard, on the recommendation of the Admission Committee, a Committee was constituted to examine the issue. The Committee after due deliberations is in agreement with the fact regarding unequal distributions of the questions asked in the aforesaid question paper. The recommendations of the Committee are as follows:-

The Entrance Examination of the aforesaid paper be cancelled and it may be conducted afresh strictly in accordance with the syllabus prescribed by the BoS of the Department of Applied Geology.

Or

Any other decision as Competent Authority deems fit.

The Coordinator Admission Cell is of the opinion that in this pandemic situation it will very difficult to conduct re-exam soon.

Resolutions:-The APC after due deliberations resolved to cancel the Entrance Test of M.Tech. (Code 203) in Applied Geology Academic Session 2020-21 held on 13-10-2020 and it may be conducted afresh strictly in accordance with the syllabus prescribed by the BoS of the Department of Applied Geology. The number of Test Centers may be minimized as far as possible.
