The Chairperson welcomed all the esteemed Members particularly New Member Prof. Ashish Verma and Special Invitees and explained the reason for calling Emergent Meeting. Thereafter, the agenda item was taken for discussion.

APC:EM:36: To consider the issue of work from home for all the Administrative and the Academic Staff excepting staff engaged in the essential/ emergency services in view of the rising cases of COVID-19 on day to day basis, for 10 days.

The Medical Officers of the University vide their note dated 07/05/2021 have reported that for last 10 days there has been sudden rise in the cases of COVID-19 infections amongst the University Employees. In order to break the chain of spread of infections, they as Medical Experts have recommended for closing the University for Minimum of 10 days in view of the safety of employees and risk involved for everyone performing the duties except for employees engaged in essential/ emergency services. To buttress their submission, the Office have placed reliance on various orders issued by Other Central Universities like BHU, Varanasi, CU, Tamilnadu, Mahatma Gandhi Antarrashtriya Hindi Vishwavidyalaya, Wardha, IGNTU, Amarkantak, allowing all the Teachers, Officers & Employees to Work from Home. It is relevant to mention here that w.e.f. 19 April 2021 the University was functioning with 50% of Group-B & C Employees and w.e.f. 22 April 2021 the University has been functioning with 10% Employees in view of the orders dated 20 April 2021 of the Govt. of M.P. and District Magistrate, Sagar.

Resolutions: The APC after due deliberations resolved unanimously to approve the proposal under the captioned agenda, allowing Work from Home to all the Administrative and the Academic Staff excepting Staff engaged in the essential/ emergency services like Security, Sanitary, Medical, Health, Electricity, Water Supply, etc. for next 10 days w.e.f. 14 May 2021 to 23 May 2021 and they will remain available on phone and as and when required they will also attend the Office/Department. The APC further resolved that keeping in view the local situation of COVID-19 Pandemic and Instructions of Ministry of Education/UGC/State/District Administration the decision may be reviewed as and when required.

The Registrar of the University, all the esteemed Members and Special Invitees paid homage to the Employees and Students who lost their lives in the ongoing pandemic of COVID-19.
