The Chairman of the Academic Program Committee gave a warm welcome to all the members.

Thereafter, the agenda items were taken up for discussion.

PART-I: ITEM FROM THE CHAIR

APC:EM:3:1(1): Consideration on Research and Academic Contribution (Category III) for minimum APIs as provided in Appendix-III to be applied for the promotion of teachers under Career Advancement Scheme (CAS) in University Departments.

The Chairman informed the Committee that there are pending cases in various departments for promotion of teachers under various stages.

The minimum APIs under category III (Research and Academic Contribution) as given in appendix III table II (A) for promotion of Assistant Professor from stage 1 to stage 2 is given as 10/year (40/ assessment period). The content in clause IV provide for APIs per year as well as per assessment period.

The explanatory note for table II (a) in clause 5 does not provide for a minimum yearly requirement of category III rather mentions about aggregate minimum score for promotion for each stage.

The matter is placed before the APC for consideration as the matter is very urgent in view of the proposed meeting of Screening Committees for various departments.

Resolution: After due deliberation, it was unanimously resolved as under:

Referring the Explanatory note for Table II (a), it is expedient that entire content of the explanation does not provide for a minimum yearly requirement of category III rather it is suggestive of aggregation of score in consideration of eligibility. This is further explained in Appendix III Table III Serial No. 4 & 5.

Since Appendix III Table II (A) contains common descriptor i.e. Research and Academic contribution (category III) with common element of expression, hence, it may be equally applied in cases of stage 2, stage 3 & stage 4. It is further stated that for category III, the minimum aggregate should be considered for determination of eligibility till U.G.C. Regulations (Second Amendment) 2013 become effective i.e. 24 July 2013.
