Minutes of the 17th Regular Meeting of the Academic Council (AC)

At the outset, the Registrar (Offg.), Shri Santosh Sohgaure as Secretary of the Academic Council extended a warm welcome to Hon'ble Vice-Chancellor and Chairperson of the AC, Prof. Neelima Gupta, and also welcomed all the esteemed members of the AC. Thereafter, the Chairperson extended a cordial welcome to all the AC members especially the external members who, in spite of their busy schedules, made it possible to attend the meeting in online mode and one external member Prof. (Retd.) Purnima P. Pattanshetti, who attended the Meeting in person. All the members also extended a warm welcome to the Chairperson. AC:17:2(ii): Award of Ph.D. Degree from 24-06-2018 to 15-09-2022.

Hon'ble Vice-Chancellor in the capacity of Chairperson of Academic Council approved the result of 220 Research Scholars for the award of Ph.D. Degree and same have been notified.

The matter is placed before the council for ratification.

Resolution: The AC after due deliberations resolved to ratify the result of the award of 220 Ph.D. Degree during the period mentioned under the captioned agenda.

AC:17:2(iii): Prospectus and Admission Brochure for the Academic Session 2022-23.

The Admission Committee of the Vishwavidyalaya prepared Prospectus and Admission Brochure for UG, PG & Ph.D. Programmes for Academic Session 2022-23 and the same was released after approval of the Competent Authority and subsequently ratified by APC in its 30th Regular Meeting. It is informed to the Council that Admission in UG and PG programmes in the Academic Session 2022-23

is being made through Common University Entrance Test (CUET) conducted by the National Testing Agency (NTA), New Delhi and in Ph.D. Programme through Entrance Test conducted by the Vishwavidyalaya.

The matter is placed before the council for ratification.

Prof. A.P. Mishra, Coordinator Admission Cell informed the AC that on the active initiative of the University Administration, the Entrance Test for UG & PG Programmes was conducted by NTA through CUET, and counseling is proposed with the active involvement of the IT Cell of the Vishwavidyalaya through Samarth Portal (Govt. of India). Many of the Central Universities are taking the help of the Samarth Portal for counseling. Prof. Mishra further informed that Entrance Test for Ph.D. Program is scheduled on 16 October 2022.

Resolution: The AC after due deliberations resolved to ratify the action under the captioned agenda.

AC:17:3(i): Constitution of Institutional Academic Integrity Panel (IAIP) and Departmental Academic Integrity Panel (DAIP).

In terms of the provisions contained in clause 11 and 10 of the University Grants Commission (Promotion of Academic Integrity and Prevention of Plagiarism in Higher Education (Institutions) Regulations, 2018, **Institutional Academic Integrity Panel (IAIP) and Departmental Academic Integrity Panel (DAIP)** have been constituted and notification thereof has been issued on 22 June 2022.

The matter is placed before the council for information.

Resolution: The AC noted the information under the captioned agenda.

PART-4: ITEMS FOR ADOPTION

AC:17:4(i): UGC (Academic Collaboration between Indian and foreign Higher Educational Institutions to offer Twinning, Joint Degree and Dual Degree Programmes) Regulations, 2022.

The UGC vide its Notification dated 2nd May 2022 has notified aforesaid Regulations. These Regulations lay down the minimum standards for academic collaboration between Indian Higher Educational Institutions and foreign Higher Educational Institutions to offer Twinning, Joint Degree and Dual Degree Programmes.

The Regulations are placed before the AC for adoption.

Resolution: The AC resolved to adopt and implement the aforesaid Regulations of the UGC.

AC:17:4(ii): UGC (Open and Distance Learning Programmes and Online Programmes) Regulations, 2020 and its subsequent Amendments.

The UGC vide its Notification dated 04 September 2020 has issued the aforesaid Regulations and its first amendment vide Notification dated 01st July 2021 and 2nd amendment vide its Notification dated 18 July 2022. These regulations lay down the minimum standards of instruction for the grant of degrees at the undergraduate and post graduate levels and grant of post graduate diploma, through open and Distance Learning mode and Online mode and shall be in addition to and not in derogation of any other regulations, Notifications, Guidelines or Instructions issued by the Commission.

The Regulations are placed before the AC for adoption.

Resolution: The AC resolved to adopt and implement the aforesaid Regulations of the UGC.

AC:17:4(iii): UGC (Credit Framework for Online Learning Courses through Study Webs of Active Learning for Yong Aspiring Minds) Regulations, 2021.

The UGC vide its D.O. F.No.1-11/2020 (SWAYAM) dated 26th March, 2021 and D.O. F.No.1-8/2017 (SWAYAM) dated 03rd June, 2022 has circulated the aforesaid Regulations for adoption. These Regulations facilitate an institution to allow up to 40% of the total courses being offered in a particular programme in a semester through the online learning courses offered through SWAYAM Platform.

The Regulations are placed before the AC for adoption.

Resolution: The AC resolved to adopt and implement the aforesaid Regulations of the UGC.

AC:17:4(iv): UGC (Promotion of Academic Integrity and Prevention of Plagiarism in Higher Educational Institutions) Regulations, 2018.

The UGC vide its Notification dated 23rd July, 2018 has notified the aforesaid Regulations.

The Regulations are placed before the AC for adoption.

Resolution: The AC resolved to adopt and implement the aforesaid Regulations of the UGC.

AC:17:4(v): UGC (Establishment and Operation of academic Bank of Credits in Higher Education) Regulations, 2021 and its first Amendment.

The UGC has notified the aforesaid Regulations on 28th July, 2021 and its First Amendment on 28th December 2021.

The Regulations and its Amendment are placed before the AC for adoption.

Resolution: The AC resolved to adopt and implement the Regulations and its Amendments mentioned under the captioned agenda.

AC:17:4(vi): UGC Guidelines for Transforming Higher Education Institutions into Multidisciplinary Institutions.

The UGC vide its D.O. No.F.1-1/2021 (Multidisciplinary/QIP) dated 02 September 2022 has circulated the "Guidelines for Transforming Higher Education Institutions into Multidisciplinary Institutions". This agenda item was included in course of meeting with the permission of the chair.

The UGC Guidelines are placed before the AC for adoption.

Resolution: The AC resolved to adopt and implement the UGC Guidelines mentioned under the captioned agenda.

AC:17:5(i): Institute of Engineering & Technology (IoET).

It is informed to the council that All India Council for Technical Education (AICTE), Govt. of India, New Delhi, vide its letter dated 15 July 2022 accorded approval for 02 New Programmes viz. UG Programme in Computer Science & Engineering (Intake-60) and UG Programme in Electronics & Communication Engineering (Intake-60) for the Academic Session 2022-23. Prof. Ashish Verma, Dean School of Mathematical and Physical Sciences, has been appointed temporarily as Incharge Director for the establishment of the Institute of Engineering & Technology. Thereafter, an Advisory Committee was constituted vide Office Order No.R/2022/71/1263 dated 28 July 2022. Board of Studies (BoS) on ad-hoc basis for both the programs were constituted vide Notification No.DoAA/BoS/2022/165 dated 04 August 2022, Notification No.DoAA/BoS/2022/166 dated 04 August 2022 and Revised Notification No.DoAA/BoS/2022/194 dated 23 August 2022. The Meeting of the ad-hoc Board of Studies (BoS) for Electronics & Communication Engineering was held on 07 September 2022 and the Meeting of the ad-hoc Board of Studies (BoS) for Computer Science & Engineering was held on 10 September 2022. The ad-hoc Board of Studies (BoS) considered the syllabus for these 02 programs and approved the same. All the requisites which are elemental to commence the courses are being complied with. A systematic roadmap along with all the requisite formalities is being devised and will be complied with in due course of time. Hence, it is expedient to commence the admission process for both courses for the current Academic Session 2022-23 as per the AICTE approval letter and on the basis of the merit of JEE Score.

The matter is placed before the council for consideration.

Prof. Ashish Verma, Director (I/c) Institute of Engineering & Technology (IoET) presented a brief on the progress of the newly approved Institute of Engineering & Technology. The AC appreciated the efforts made by Prof. Verma and Hon'ble Vice-Chancellor Prof. Neelima Gupta on this achievement.

Resolution: The AC after due deliberations resolved to approve the proposal under the captioned agenda.

(Action: Director (I/c) IoET and Coordinator Admission Cell)

AC:17:5(ii): Commencement of 02 PG Courses in the Department of Management from Academic Session 2022-23.

It is informed to the council that All India Council for Technical Education (AICTE), Govt. of India, New Delhi, vide its letter dated 03 July 2022 accorded approval for 02 New PG Courses for Dept. of Business Management, viz. MBA in Travel & Tourism Management (Intake-60) and MBA in Health Care & Hospital Management (Intake-60) for the Academic Session 2022-23. The APC in its 30th Meeting approved the syllabus of both the courses.

The matter is placed before the council for consideration.

Dr. Shree Bhagwat, Head, Dept. of Business Management apprised the AC on the progress of the newly approved courses. The AC appreciated the efforts of HoD, Dept. of Management, Dean School of Commerce and Management and Hon'ble Vice-Chancellor for getting the approval of AICTE for 02 New PG Courses.

Resolution: The AC after due deliberations resolved to approve the proposal under the captioned agenda.

(Action: HoD, Dept. of Management and Coordinator Admission Cell)

AC:17:5(iii): Implementation of NEP 2020 in the Vishwavidyalaya from Academic Session 2022-23.

The NEP 2020 Implementation Committee of the Vishwavidyalaya prepared a template of Curriculum Framework 2022 based on National Education Policy 2020 and same was approved by the APC in its 43rd Emergent Meeting. The template so approved was circulated to all the Departments of the Vishwavidyalaya for consideration by the respective BoS. The BoS of the respective Departments has modified/changed the syllabus accordingly and they are presented in the current meeting.

The matter is placed before the council for consideration.

Prof. A.D. Sharma, being a Chairperson of the NEP-2020 Implementation Committee, presented a brief regarding the progress of implementation of NEP-2020 in the Vishwavidyalaya.

Resolution: The AC appreciated the efforts made by Prof. Sharma and his team for the implementation of NEP-2020 and after due deliberations resolved to approve the implementation of NEP-2020 in the Vishwavidyalaya from Academic Session 2022-23.

(Action: DoAA and Chairperson of NEP-2020 Implementation Committee)

AC:17:5(iv): Amendment in Ordinance 57 on Medals from Endowment Funds.

As per the existing Ordinance effective from 07-12-2016, the minimum amount of

endowment is Rs.1,00,000/- (Rs. One Lakh) only. The interest accrued on the present minimum amount of Rs.1,00,000/- is not sufficient to be utilized for the award of a Medal. Hence, it is proposed to enhance the minimum amount of Rs.5,00,000/- (Rs. Five Lakh) only.

The matter is placed before the council for consideration.

Resolution: The AC after due deliberations resolved to approve to enhance the minimum amount of endowment to Rs.2,50,000/-. The AC further resolved to amend Ordinance 57 accordingly and place it before the Executive Council for final decision.

(Action: Deputy Registrar, Academics)

AC:17:5(v): Ordinance on Courses of Study for the award of Bachelor of Technology (B.Tech.) Degree.

In terms of the provisions contained in section 28(1)(b), 28(1)(c) and 28(1)(g) of the Central Universities, Act, 2009, Ordinance on Courses of Study for the award of Bachelor of Technology (B.Tech.) Degree under the Institute of Engineering & Technology (IoET) is proposed for consideration.

Resolution: The AC after due deliberations resolved to approve the Ordinance under the captioned agenda and recommended to place it before the Executive Council for consideration.

(Action: Deputy Registrar, Academics)

AC:17:5(vi): Amendment in Ordinance 23(A) on Admission, Examination, and Evaluation for the Award of Doctor of Philosophy (Ph.D.).

The amendment is proposed in terms of the First & Second Amendments in UGC Regulations 2016 governing Ph.D. Programme and also in scheduled 1 of Ordinance 23(A) i.e. Regulations governing Ph.D. Programme taking into account the functional convenience.

The matter is placed before the council for consideration.

Some of the esteemed members suggested that Ordinance 23(A) requires to be reviewed thoroughly as there is no period specified within which Research Supervisor should be allocated for an admitted Research Scholar. The external examiners on the Panel may be preferably in the rank of Professor or in an equivalent position not below the rank of Associate Professor. The Research Scholar should be given the liberty to prepare a thesis on both sides of the paper.

Resolution: The AC after due deliberations resolved that Committee working on Subordinate Legislation should revisit Ordinance 23(A) keeping in view the suggestions given by the esteemed members and proposed amendments accordingly. The AC further resolved that Committee may, if required, co-opt other faculty members for better input.

AC:17:5(vii): Amendment in Statute 15 on Schools of Studies.

Under the existing Statute 15, Department of Business Management is under the School of Commerce and Management. It has been proposed by the Department that courses run under the Department are regulated by AICTE, hence it would be expedient to place the Department under a separate school named as 'School of Management Studies'. Accordingly, amendment is proposed in the existing Statute 15.

The matter is placed before the council for consideration.

In course of the discussion, the HoD, Dept. of Pharmacy emphatically submitted that as per the requirement of the Pharmacy Council of India, Pharmacy courses for the award of Diploma /Degree Certificates should be conducted under the "Faculty of Pharmacy" or "Faculty of Pharmaceutical Sciences" only. The Department has already submitted the proposal regarding the formation of a separate school for the Dept. of Pharmaceutical Sciences.

Resolution: The AC after due deliberations resolved to approve two new schools, namely, "School of Management Studies" and "School of Pharmaceutical Sciences" and recommended to place it before the Executive Council for consideration.

(Action: Deputy Registrar, Academics)

AC:17:5(viii): Amendment in Ordinance 7 on Departments in Schools of Studies.

Under the existing Ordinance 7, there is a provision under clause 2 that the University may add new School(s)/ Department(s)/ Center(s) to a school which does not exist presently after obtaining prior administrative approval of the UGC. This provision appears to be in conflict with Statute 15(5)(a) of the Statutes contained in the Second Schedule of Central University Act, 2009, which provides that every school shall consist of such departments as may be assigned to it by the Ordinances;

Provided that the Executive Council may, on the recommendation of the Academic Council, establish Centres of Studies to which may be assigned such teachers of the University as the Executive Council may consider necessary. Further, as per Statute 37(5), every Ordinance made by the Executive Council shall come into effect immediately. Hence, proposed amendment in the aforesaid Ordinance is as under:-

The University may add New Department(s)/ Centre(s) to a School/ which does not exist presently after approval of the Executive Council on the recommendation of the Academic Council.

The proposed amendment is placed before the council for consideration.

Resolution: The AC after due deliberations resolved to approve the amendment under the captioned agenda and recommended to place it before the Executive Council for consideration.

(Action: Deputy Registrar, Academics)



AC:17:5(ix): Revision in Fee Structure for various programmes for Academic Session 2022-23

The APC in its 30th Regular Meeting held on 16 August, 2022 approved the Report of the Fee Committee for various programmes for Academic Session 2022-23.

The salient features of the Report of the Fee Committee are as under :-

- a) For UG, PG & Ph.D. Courses, IT fee is proposed to be increased by Rs.550 to recoup the actual expenditure on IT services.
- b) Other fee structure will remain the same.
- c) The fee structure of Ph.D. course has also been rationalized with small increase in tuition fee, lab fee and library fee.
- d) Fee structure for foreign students for UG & PG Course has also been decided.

The Fee Committee also revised the fee structure of existing programmes run by the Institute of Distance Education (IDE) and the Hostel Fee with the consultation of Chairman, Council of Wardens.

The matter is placed before the council for consideration.

In course of the discussion, the Director (I/c) Institute of Engineering & Technology submitted a proposal for a fee structure for B.Tech. Courses to the tune of Rs.20,000/- per semester.

Resolution: The AC after due deliberations resolved to enhance the fee structure for the B.Tech. Courses to the tune of Rs.25,000/- per semester and approve the Report of the Fee Committee under the captioned agenda. The AC further resolved the fee structure for the MBA in Health Care & Hospital Management and MBA in Travel and Tourism Management; and recommended to place these fee structures before the Finance Committee for consideration.

(Action: DoAA and Finance Officer)

AC:17:5(x): Formation of University Panel of Experts for Screening-Cum-Evaluation Committees/ Selection Committees for promotion under CAS and for Selection Committees for appointment of teachers in different departments and Other Academic Posts as per UGC Notification No.F-1-2/2017/(EC/PS) dated 18 July 2018.

The matter is placed before the council for consideration.

Resolution: The AC after due deliberations resolved to approve the Panel of Experts submitted by the Departments. The AC further resolved to authorize the Vice-Chancellor to expand the panel, as and when required.

AC:17:5(xi): Syllabi revised by the BoS of the Department concerned for UG & PG Programmes in light of NEP 2020.

BoS of the Department concerned has modified/changes syllabus for UG & PG Programmes in light of NEP 2020. A presentation of the same shall be given by the respective HoDs.

The matter is placed before the council for consideration



Resolution: The AC after due deliberations resolved to approve the Syllabi revised by the BoS of the Department concerned.

(Action: DoAA and Heads of the Departments)

AC:17:5(xii): Minutes of the School Boards.

The Minutes of the School Boards are placed before the Council for consideration. The brief shall be given by the respective Deans of Schools.

The matter is placed before the council for consideration.

Resolution: The AC after due deliberations resolved to approve the Minutes of the School Boards.

PART-6 : ANY OTHER MATTER WITH THE PERMISSION OF THE CHAIR

AC:17:6(i): With the permission of the Chair, the following two proposals were placed before
EOM: the Academic Council for the smooth conduct of Dr. Ambedkar Centre of Excellence (DACE).

- a) To conduct a Walk-in-interview for the appointment of Guest Faculty till the contractual/ term appointment of teachers is made in the DACE/newly created courses in B.Tech./Management.
- b) To approve the Honorarium to the Regular/ Retired Teachers who are invited to take classes for free coaching to the SC students.

Resolution: It was informed to the AC that during the review meeting of DACE with the Hon'ble Minister of State for Social Justice and Empowerment, Govt. of India, held on 22-09-2022 at 10:00 AM through video conferencing, it was laid emphasis to start DACE Programme by 01-10-2022 and teachers should be appointed by the said date. However, it is practically not possible to appoint teachers within a short span of time. The AC after due deliberations resolved to approve the proposal to conduct a walk-in interview for Guest Faculty and to pay an Honorarium at the rate prescribed by the UGC to the Retired Teachers (upto 70 years) who are invited to take classes in the DACE. For regular Teachers, the matter may be considered by FC/EC. A similar procedure may be adopted for new B.Tech. and Management courses.

The meeting ended with a vote of thanks to and from the Chair.
