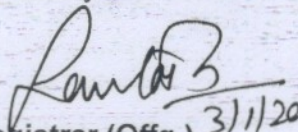

Sub: Preventive steps to control the re-spread of COVID-19 reg.-

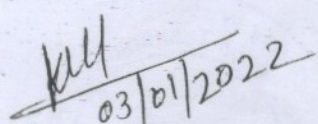
1. In view of the new variant **Omicron** and rise in **COVID-19** cases the worldwide, in India and now in Sagar and in the University as well and also keeping in the mind about impact of previous first and second wave, it is necessary that all Faculty members, Officers, Staff members and Students should follow the COVID appropriate behaviour scrupulously. This will ensure in checking the spread of this pandemic in the University Campus.
2. The following instructions are being issued for **strict compliance** by the all Faculty members, Officers, Staff members and Students of the University, with immediate effect:
 - (i) Face cover/mask must be worn at all times inside the University premises i.e. in all/Dept/Office/Sections etc.
 - (ii) Vaccination for COVID-19 of everyone must be completed as per the guidelines at the earliest, if anyone who is not vaccinated yet must strictly comply to get vaccinated except for any specific health contraindications for vaccination.
 - (iii) It is advisable to all the concerned to have mandatory thermal screening at the entry point of their work places while maintaining social distancing norms.
 - (iv) Seating arrangement in offices etc. should be made in such a way that adequate social distancing is maintained;
 - (v) Crowding/gathering and loitering inside office premises/corridors canteens/parking etc. should be avoided at all times;
 - (vi) Ensure COVID appropriate behaviour viz, frequent washing of hands with soap and water, use of sanitizers and maintaining appropriate physical distance (*Do Gaj ki Doori*);
 - (vii) Proper cleaning and frequent sanitization of the workplace must be ensured by the Controlling Authority of respective Departments/Offices/Centres etc.
 - (viii) Strict compliance of instructions of COVID-19 appropriate behaviour issued by Ministry of Home Affairs, Ministry of Health & Family Welfare, Ministry of Education/ UGC and District Administration, Sagar from time to time.
