At the outset, the Registrar (Offg.) Shri Santosh Sohgaura as Secretary of the Executive Council extended a warm welcome to Hon'ble Vice-Chancellor & Chairperson of the EC, Prof. Neelima Gupta, and also welcomed all the esteemed members of the EC. Thereafter, the

Chairperson extended a cordial welcome to all the EC Members.

Thereafter, the Single Point Agenda item was taken for discussion. While discussing the Agenda Item, the comments of CU Bureau, Govt. of India, Ministry of Education, Department of Higher Education as communicated by Shri Vijay Kumar, Under Secretary, vide his letter F.No.56-2/2022-CU IV dated 02.03.2022 were taken care of and the following are the resolutions of the Council:

ITEM :1	Consideration of Recommendations of Selection Committees held in January & February 2020 in respect of Group-A Non-teaching Positions and related issue, in pursuance of the order dated 08.02.2022 passed by the Hon'ble High Court of M.P. at Jabalpur in W.A. No.1012 of 2020.
	The Vishwavidyalaya issued an Advt.No.R/A-NT/2019/001 dated 01.03.2019 for filling up vacant posts of Group-A, B and C. However, the selection process for Group 'B' & 'C' and also for the posts of Assistant Registrar, (lien vacancy), Networking Administrator, Senior System Analyst and Public Relation Officer under Group A could not be completed within the period stipulated in DoPT OM F.No.Misc-14017/15/2015-Estt.(RR) dated 11-01-2016 and the same was subsequently cancelled with the notification that fresh recruitment process will be initiated shortly and the candidates, who have already been declared eligible by the Screening Committees, need not apply again and it was reported in EC in its 24th Meeting held on August 19, 2019, vide item No.EC-XXIV-(II)-(viii). Thereafter, the Vishwavidyalaya issued an Advt.No.R/A-NT/2019/004 dated 13.09.2019, whereby, 25 Non-teaching vacant posts of Group A, B and C were sought to be filled, out of which 7 posts were for "Group A" interviewed (during 09.01.2020 to 20.02.2020). While in Group B for '9' posts, the Written and Skill Test for the posts of 'Section Officer', was conducted on 04.01.2020. In so far as remaining 8 posts i.e. Nursing Officer, Horticulturist, Assistant Statistical Officer, Personal Assistant, Security Officer, Private Secretary, Physiotherapist, Accompanist (Tabla), were concerned, only the written test was conducted during the period 15.02.2020 to 16.02.2020, However, Skill Test could not be held. Similarly, in Group 'C' for '9' posts, the Written and Skill Test was held for the post of Lower Division Clerk (LDC) and 'Laboratory Attendant' on 05.01.2020 and 04.01.2020, respectively. But for the remaining 6 posts, namely, Semi Professional Assistant, Sanitary Inspector, Sanitary Supervisor, Pharmacist, Technician Pathology, Security Inspector, only written tests were held from 15.02.2020 to 16.02.2020. However, Skill Test could not be held. Further, for the post of Section Cutter, no candidate was found eligible.
	The appellant, Deepak Singh Maravi, called in question the Advertisement dated 13.09.2019 in W.P. No.2869/2020. While entertaining the said Writ Petition, the Ld. Single Judge vide its interim order dated 05.02.2020 directed that the final select list shall not be published by the Vishwavidyalaya. In view of the aforesaid interim order, the results of respective tests for the posts, which were advertised vide Advertisement dated 13.09.2019, could not be declared. Besides, the remaining skill tests for certain Group B and C could not be held. It is expedient to state that the Vishwavidyalaya had also issued an Advt.No.R/A-NT/2019/002 dated 18.07.2019, whereby, 4 posts were advertised. In that, a Written Test for the post of Junior Engineer (Civil) was conducted, but its result was not declared. Further, the Vishwavidyalaya has also issued another Advt.No.R/A-NT/2019/003 dated 20.08.2019, which was subsequently modified vide Advt.No.R/A-NT/2019/005 dated 26.12.2019. In that, Group C '10' posts were advertised, for regularization of existing Daily Wages/Muster Roll Employees. The Written Test and Skill Test for the said 10 posts were held from 12.01.2020 to 14.01.2020. Though aforesaid

was in vogue, accordingly, the results of said posts were not declared.

however, due to abundant precaution and the interim order dated 05.02.2020,

Aforesaid interim order dated 05.02.2020 stood vacated, with the dismissal of aforesaid Writ Petition vide final judgment dated 31.08.2020. Aggrieved by aforesaid, present appeal was preferred. It is of significance that, during the pendency of Writ-Petition, the tenure of Regular Vice-Chancellor expired on 20.08.2020, thus the duties of Vice-Chancellor, to the extent necessitated by the provisions of rules, in vogue, were performed by In-charge Vice-Chancellor. Moreover, the Ministry of Human Resources Development (now Ministry of Education) vide its order dated 06.03.2020, directed, that the Acting Vice-Chancellor of the Central University should not take the decision regarding recruitment. Resultantly on dismissal of W.P. No.2869/2020, there being no regular Vice-Chancellor, as such, results of posts in question could not be declared. The regular Vice-Chancellor joined on 25-09-2021. It is worthwhile to quote the provisions contained in DoPT order F.No.14017/15/2015-Estt. (RR) dated 11-01-2016 which is as follows:

"It may be ensured that the entire recruitment process including and starting from advertisement, conducting written examination or holding interview may be completed within six months."

Further, the OM dated 29 March 2004 of the Govt. of India, Ministry of Personnel, PG and Pensions, Department of Personnel and Training, New Delhi, provides as under:-

The period of validity of the panels recommended by the Screening Committees for appointments to posts in Autonomous/Statutory organizations may be restricted to a ceiling of one year. The date of commencement of validity of the Panel will be the date on which the Selection Committee makes the recommendation.

On the basis of aforesaid facts and rule positions, the following issues emerge to be decided:

- 1. Whether the pending recruitment process may be scrapped and vacant posts may be advertised afresh so that opportunity to apply may be provided to fresh candidates who become eligible during this period?
- 2. Whether the process for declaring the result of the examinations already conducted may be initiated?
- 3. Any other action, as deems fit, may be taken in the instant case.

On the aforesaid issue, legal opinion was sought from the Panel Advocate of the Vishwavidyalaya on 27 December 2021. The Senior Advocate Smt. Shobha Menon rendered a legal opinion that it would be appropriate to prefer Application for passing orders along with Application for Urgent Hearing in the aforesaid Writ Appeal. On the said Application (I.A.No.509/2022) in the aforesaid Writ Appeal No.1012/2020, Hon'ble High Court passed the order on 08-02-2022, the operative part thereof is as follows:

It is pertinent to mention here that against the aforesaid

Advertisements 01 Advertisement was for Regularization of Daily Wages (working in this Vishwavidyalaya since long). Applications were received in the Vishwavidyalaya Recruitment Cell and after conducting screening of the Applications, the entire data pertaining to the candidates were provided to an outsource agency M/s WeShine Tech Pvt. Ltd. Puna (Selected through the tendering process) for conducting the Test of eligible candidates as per the syllabus prescribed by the Vishwavidyalaya and uploaded on the Vishwavidyalaya Website. As per the syllabus prescribed there was an Online MCQ Test for all Non-teaching positions. Thereafter, there were Descriptive Type Tests and Skill Tests, where ever applicable. The entire confidential work like the setting of question papers, the conduct of online Written Tests and evaluation of answer scripts was assigned to the hired Recruitment Agency. In order to shortlist the eligible candidates for appearing in the interview in the order of merit restricting the ratio to 1:15 as prescribed in the CRR 2018, the Objective Type Test was conducted through the aforesaid agency for the posts of Assistant Registrar, Public Relation Officer, Networking Administator and Senior System Analyst. The Result of Objective Type Test was declared and the shortlisted candidates in order of merit in the ratio of 1:15 were allowed to participate in the interview conducted in the Month of January/ February 2020 by Selection Committees constituted by the Vishwavidyalaya as per CRR 2018. The interview for the eligible candidates for the posts of other Academic Posts namely Librarian, Deputy Librarian and Director, Physical Education was conducted by the Selection Committee constituted by the Vishwavidyalaya as per UGC Regulations 2018. It was also placed in the 26th Meeting of EC held on 07-02-2020 and the EC after due deliberation resolved not to open the envelopes and authorized the Vice-Chancellor to open the envelope and approve the recommendations of the Selection Committees when the interim order is vacated by the Hon'ble High Court. The recommendations of the Selection Committee for the following Group-A posts are in a sealed envelope. The details of the posts for which the Selection Committee held are as under:

- 1. Librarian
- 2. Director, Physical Education
- 3. Deputy Librarian
- 4. Senior System Analyst
- 5. Assistant Registrar (Lien Vacancy)
- 6. Networking Administrator
- 7. Public Relation Officer (PRO)

It is informed to the Council that 02 Posts of Assistant Registrar (Lien Vacancy) were advertised. However, no Lien Vacancy is existing as on date.

It is further informed to the Council that as per clause 7 of the work order dated 28-11-2019 issued by the then Registrar to the M/s WeShine Tech Pvt. Ltd stipulates that the said firm will contact & report to the Registrar of the Vishwavidyalaya. As per Office Report, Hard Copy of the documents/ papers related to recruitment for the posts of Section Officer, Lower Division Clerk, and Lab Attendant Posts for which process are said to be concluded and also documents related to conduct of Written Tests for Other Group-B & C Posts are not presently available with the Office of the Vishwavidyalaya and the Officiating Registrar of the Vishwavidyalaya vide his letter dated 24-02-2022 requested the then Registrar Col. R.M. Joshi presently posted as Registrar in TISS Mumbai to apprise the actual status of the recruitment for Group-B & C posts against the aforesaid Advertisements within a period of 3 days and his response in this regard is awaited.

RESOLUTION: The Executive Council after due deliberations resolved to open the Sealed Envelopes for all the Non-teaching Group-A posts whose entire selection process has been completed; except for the posts of Assistant Registrar (Lien Vacancy) as no lien vacancy exists as on date. Thereafter, the Sealed Envelopes containing the recommendations of the Selection Committees were opened before the Executive Council and the Council considered and unanimously resolved to approve the recommendations of the Selection Committees for the following Group-A Non-teaching posts:
