FC-11-4-4 Consideration and adoption of Annual Accounts for the FY 2008-2009

on prescribed format of UGC

Resolution: The Finance Committee Considered the Account of the University for

the year 2008-09 and recommended to the Executive Counsel for its adoption. The receipt and payment Account includes the details of grants received upto January 2009 from the state Government of Madhya Pradesh and thereafter from UGC. The details of payment upto January 2009 out of state grant and thereafter from the UGC grant have been shown separately in the Annexure of the account.

FC-11-4-5 Consideration on the Endowment Fund to award the Medal and growth of the University.

Resolution: A. The Committee discussed on the issue of the Endowment Fund and unanimously resolved that there Shall be one Endowment Fund in place of Individual Account. The medals and scholarship will be awarded from the interest of the Endowment Fund.

B. Committee has also discussed on the issue of transfer of interest on investments. It is viewed that the same be transferred to Endowment Fund to meet the Endowment objective effectively.

C. The finance committee apprised the matter of savings from the internal receipts w.e.f. the F.Y. 2008-09 to 2010-11. The committee unanimously resolved that the savings out of internal receipts shall be transferred to Endowment Fund to fulfill the growth, objective of the university under the guidelines of the UGC. The University will follow the guidelines mutatis and mutandis.
