where,

 M is the marks obtained by the candidate in the paper, mentioned on this score card in GATE 2017 M_q is the qualifying marks for general category candidate in the paper $\bar{M}_t$ is the mean of marks of top 0.1% or top 10 (whichever is larger) of the candidates who appeared in the paper (in case of multi-session papers including all sessions) $S_q = 350$, is the score assigned to M_q $S_t = 900$, is the score assigned to $\bar{M}_t$ In the GATE 2017 score formula, M_q is usually 25 marks (out of 100) or $\mu + \sigma$, whichever is greater.
