Approval of courses and manpower for strengthening of School of Education/Faculty of Education in Central Universities – Dr. Harisingh Gour Vishwavidyalaya.

Sir,

This is in reference to your office letters No. (i) R/2015/831 dated 02.12.2015 (ii) R/Edun/PMMMNMTT/2015/843 dated 4.12.2015 regarding the requirement for approval of courses and manpower for establishment of School of Education/Faculty of Education in your university. The proposal was placed before the Committee constituted for the purpose. The Committee recommended that it is not desirable to permit the university to approve the B.Ed.+M.Ed. (First Disability Specialisation)+B.Ed.+M.Ed, (Second Disability Specialisation) and B.A.Education at this stage as UGC has a separate scheme for Teacher Preparation in Special Education (TEPSE) which is meant for assisting Department of Education to launch special education teacher preparation programmes to prepare special teachers to teach children with disabilities in both special and inclusive settings, the Committee did not recommend additional teaching positions for B.Ed. and M.Ed. (Special Education), so university may apply separately under this scheme. Therefore, the Committee recommends that university may be given 16 teaching positions to fill up the gap for B.A.B.Ed. (Integrated), B.Sc.B.Ed.(Integrated) and M.Ed. course as per new norms prescribed in NCTE Regulations, 2014. The recommendations of the Committee were placed before the Commission in its 513<sup>th</sup> meeting held on 29<sup>th</sup> February, 2016. The Commission considered and approved the recommendations of the Committee. Accordingly, the undersigned is directed to convey the approval of UGC for creation of 16 teaching positions to fill up the gap for B.A.B.Ed./B.Sc.B.Ed. and M.Ed. programme as per new norms prescribed in NCTE Regulations, 2014 for strengthening of School of Education/Faculty of Education as per

The expenditure on the above teaching positions may be incurred out of the funds provided under salary head of the XII Plan allocation.

The approval of the above is subject to fulfillment of the following:-

- The University may frame the cadre recruitment rules for each category of posts approved by UGC.
- (ii) The University may strictly adhere to the reservation policy for SC/ST/OBCs/PH as per Govt. of India guidelines while filling up these posts.
- (iii) The University may fill up the sanctioned teaching posts in a phased manner as per actual requirement of University under intimation to UGC.
- (iv) 50% of the teaching positions (8 teaching positions) may be filled up as Guest Faculty/contractual faculty till the decision is taken by Review Committee constituted by NCTE regarding duration of the M.Ed. course.
