Summary Record of discussions of the Fourth Project Approval Board(PAB) Meeting of the Pandit Madan Malaviya National Mission on Teachers and Teaching (PMMMNTT) held on 15th December, 2015

The Fourth Project Approval Board (PAB) Meeting of the Pandit Madan Malaviya National Mission on Teachers and Teaching (PMMMNTT) was held under the Chairpersonship of Secretary (HE) on Tuesday, 15th December, 2015 in at 2.30 PM in Conference Room 112-C Wing, Shastri Bhavan, New Delhi to consider various proposals received from different universities/institutes for different components of the scheme. Secretary (SEL), MHRD could not attend the meeting and was represented by Shri J. Alam, Joint Secretary (TE), MHRD. The list of participants is at **Annexure I.**

2. At the outset of the meeting, Joint Secretary (Policy) welcomed the PAB members and the participating representatives of various universities/institutes attending the meeting.

3. The minutes of the Third PAB meeting held on 9.09.2015 were confirmed.

4. Thereafter, the Chair invited the proposing institutions to make a presentation on the proposals submitted. A total of 13 proposals from 12 institutions were being considered in this PAB meeting as shown at **Annexure II.** Only 11 institutions were present in the PAB meeting. Tamil Nadu Physical Education and Sports University was not present for the meeting.
