The Board of Studies approved the list suggested to the inclusion of details of each ~~examiners~~ experts.

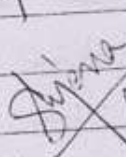

An emergency meeting of the BOS ~~was~~ was held in the department on 23.02.2018. Following members were present in the meeting.

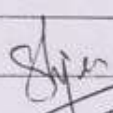

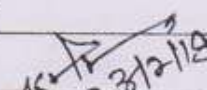

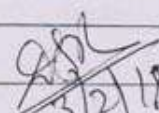
