Resolution: The committee authorized to ~~be~~ (Bos) for preparation of examiners on ~~an~~ subject- expert list.

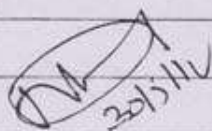

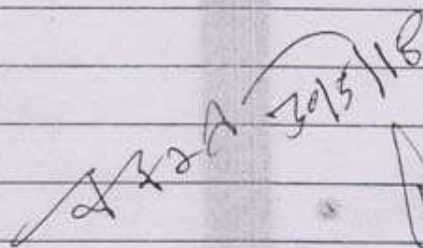
Resolution: These Certificate Course may be introduced as add-on courses.

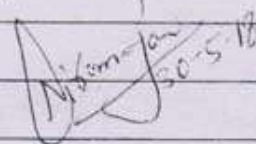
Suggestion: The Committee suggested for introducing one certificate course on cultural value practices in 21's relevant for the self employment.

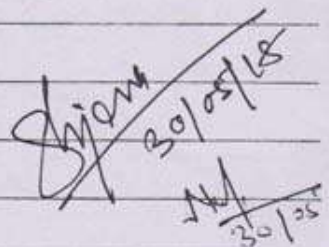

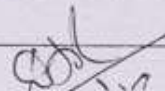
